### 申请纽约市死亡证明的 3 种方式

- 在线:访问 nyc.gov/vitalrecords,使用信用卡、借记卡或电子支票进行订购。"只有配偶、非婚姻同居伴侣、 父母、兄弟姐妹、祖父母、孙子女或负责处理死亡证明的人员(提供资料的人员)才可在线提交订单"。
- 来访: 前往位于下曼哈顿区的 125 Worth Street, 从 Lafayette Street (无障碍通道) 或 Centre Street 入口进入。 我们的工作时间为周一至周五上午9:00至下午3:30。早上排队的人最少。
- 邮寄:通过邮寄提交的申请必须在公证人员面前进行签名。请将您的申请邮寄至 125 Worth Street, CN-4, New York, NY 10013。请务必将支付的支票或汇票(抬头为 "NYC Department of Health and Mental Hygiene") 与 一枚贴上邮票的回邮信封一同寄送给我们。您必须提供第1类身份证明的复印件或2类身份证明的原件副本 (参见下文)。

## 已故者的配偶、同居伴侣、父母、兄弟姐妹、祖父母、孙子女,或负责处理死亡证明的人员(提供资料的人 员)申请死亡证明时的身份证明(ID)要求

我们接受以下任意身份证明,前提是其中包含您的照片和签名且未过期:

- 驾驶证或非驾驶员的身份证
- 带照片的 NYS 保障卡
- 美国或外国护照或护照卡
- 永久居民卡
- 大学或学院学生证及最近成绩单

- NYC 残障专车 (Access-A-Ride) 卡
- IDNYC 市民身份证
- NYC MTA 优惠地铁卡

### 如果您无法提供上述资料,我们也可接受:

- 下方注明的两类不同文件显示您的姓名和地址,前提是文件日期在过去 60 天以内,且我们将以**邮寄**方 式发放死亡证明
  - 。 水电或电话账单
  - 您收到的政府官方邮寄资料

## 与已故者无关联的申请人的文件要求

如果您与己故者无关联,需确认您有权利获取其死亡证明。如果您是房产的法定代理人、保护或维护不动产权的一方, 或您可说明其他司法或其他合法用途, 可获得死亡证明。

- 保单
- 遗嘱
- 银行存折或对账单
- 房产契据
- 其他能证明您权利的文件

- 服刑人员身份证及最近释放文件
- 工作证及最近工资存根

- Falsifying information, including forging a signature, to obtain a death certificate is a misdemeanor and violators may also be subject to a fine of up to \$2,000 per violation.
- Submitting fraudulent identification is a crime and violators are subject to prosecution.
- Please see below for identification requirements, fees and other important information.
- ID requirements are subject to change.

### 3 Ways to Order a New York City Death Certificate

- Online: Visit <u>nyc.gov/vitalrecords</u> to order using a credit card, debit card or electronic check. "Only spouses, domestic partners, parent, siblings, grandparent, grandchild, or person in charge of the disposition (informant) may submit orders online."
- **Walk-In:** Go to 125 Worth Street in Lower Manhattan and use the Lafayette Street (handicapped accessible) or Centre Street entrances. We are open Monday through Friday 9:00AM 3:30PM. Lines are shortest in the morning.
- By Mail: Applications submitted by mail must be signed in the presence of a Notary Public. Mail your application to 125 Worth Street, CN-4, New York, NY 10013. Be sure to include a self-addressed, stamped, envelope with your check or money order payable to the NYC Department of Health and Mental Hygiene. You also will need to provide a photocopy of the required identification and any necessary documentation (see below).

Identification (ID) requirements including the deceased's spouse, domestic partner, parent, sibling, grandparent, grandchild, or person in charge of the disposition (informant)

We accept any of the following, IF it includes your photo, your signature and is unexpired:

- Driver's License or Non-driver's ID Card
- NYS benefit card with photo
- U.S. or foreign passport or passport card
- Permanent resident card
- University or college ID with a current transcript
- Inmate ID with current release papers
- Job ID with a current pay stub
- NYC Access-A-Ride card
- IDNYC Municipal ID
- NYC MTA reduced fare card

#### If you don't have any of the above, we also accept:

- Two different documents as indicated below if they show your name and address and are dated within the past 60 days, we will MAIL the certificate
  - Utility or telephone bills
  - Official government mail that you have received

## Documentation requirements for applicants NOT related to the deceased

If you are **not** related to the deceased, you need to establish your right to obtain a death certificate. You may obtain a death certificate if you are the legal representative of the estate, a party with a property right to protect or assert, or if you can specify another judicial or other proper purpose.

- Insurance Policy
- Will
- Bank Book or statement
- Property Deed
- Other document showing entitlement
